Re Official Information Request - Costs of treating patients not eligible for publicly funded care

I refer to your official information request dated 13 August 2018 for the following information:

Could you please give me the total cost of treating patients not eligible for publicly funded care in the last year, and compared to the last five years? And how much of that was recouped:

- From the patients/their private insurance
- From the Ministry of Health?

Specifically, could you tell me about the number of patients and cost of care for ineligible patients:

- Receiving dialysis
- Receiving treatment for diabetes
- Have other pancreatic issues
- Requiring treatment at Greenlane Eye Clinic
- Requiring cardiac care?

Plus the overall cost of translation services.

May I also add in (just to be totally clear) how much of the costs – in the questions about how money is recouped - are eventually paid for by the DHB itself, and whether that comes from a general operating fund or a specific fund?

We have provided the information in response to your questions below.

## Please note:

- The response to all questions excludes patients referred to Auckland DHB who are funded by Pacific governments and aid schemes.
- Our revenue billing system does not hold information on patient diagnosis and treatments. We have therefore provided information based on the clinical service from which the treatment was billed. This will exclude billing from general services such as Emergency Department and General Medicine.
- We do not have a separate pancreatic service, so therefore we are unable to provide a response in relation to pancreatic issues.
