

Thank you for your interest in the communications for our vaccination programme. I refer to your Official Information Act request dated 8 December 2021, which was subsequently re-scoped in consultation with TAS on 15 December 2021, requesting the following information:

I am a Research Fellow at the Faculty of Law, University of Otago. I am researching the use of visual imagery used by district health boards to communicate COVID-19 related legal information to the public. I am seeking the same information from all the district health boards as part of my research into visual jurisprudence and the communication of COVID-19 related information in visual form. I am making this request under the Official Information Act 1982, for all written and visual material, communications, emails, design drafts, final papers and decisions related to all visual material created for COVID-19 vaccination communications from the DHB, since January 2021, including:

- The COVID-19 vaccination design briefs developed by DHB staff, advisors and contractors; all relevant internal and external communications in relation to the development of the design briefs, all decision-making papers, notes, emails, minutes and agendas in relation to the design briefs; and
- all external communications in relations to COVID-19 vaccination design briefs, including draft and final visual material, responses from and to external agencies and creatives concerning the COVID-19 design material; all communications seeking advice from and giving advice to internal and external partners and parties on the COVID-19 visual and design material.

I am responding on behalf of the Northern Region Health Coordination Centre (NRHCC), the COVID-19 response and vaccination team set up by the Northland, Waitematā, Auckland, and Counties Manukau District Health Boards (DHBs).

The included material relating to vaccination does not have the requested corresponding design briefs, draft visual material or communications as the NRHCC Communications team is currently fully committed to the ongoing rollout of the Vaccination programme and responding to the Omicron outbreak.

As evident by the large quantity of work produced by the team and as provided in attached appendices, additional resource would be required to collate the above information - an

approach you previously indicated with TAS you did not wish to pursue as it would involve charging you.

We are, therefore, refusing this aspect of your request under section 18(f) of the OIA due to substantial collation.

However, we have provided an overview of the process for development of communications materials and assets for general audiences as well as Māori, Pacific peoples and Asian and MELAA communities to help provide further context.
