Re Official Information Request – Professionals working in NZ from overseas

I refer to your official information request dated 8 July 2020 requesting the following information:

I'm a Stuff reporter looking into the effect Covid has had on the health sector, given many health professionals working in New Zealand come from overseas. I'm asking all DHBs about the impact this has had on them.

I would like to know:

1. What percentage of your usual clinical workforce is overseas-trained?

Auckland DHB does not keep records of whether an employee is overseas trained or not, however, as part of the quarterly data submissions to TAS, they have provided us with this data for our recent submission as at 30th March 2020.

3. What impact do you expect border restrictions to have on the DHB workforce over the next year?

We expect border restrictions to have a minimal impact on Auckland DHB's workforce as we can still bring in qualified healthcare workers under the immigration exemptions processes and our turnover rates are lower than usual which has reduced the volume pressure.

4. Are there specialities likely to be under pressure as a result of border restrictions? For example, because there is a small workforce in New Zealand or because of overseas training needs. If so, which specialties?

As per above, there is not likely to be any pressure on any specialty due to the border restrictions themselves as there are exemptions for qualified healthcare workers.

5. Is your DHB currently recruiting for any clinical positions which you cannot fill with New Zealand applicants?

Yes, this is the ongoing normal situation that fluctuates across positions types. It is hard to be definitive with such questions as over time the situation can change quite significantly.
