Re: Official Information Act request – Cystic Fibrosis Costs

I refer to your Official Information Act request dated 22 February 2021 requesting the following information:

My name is Edward Lee, I am involved in the effort to get Trikafta funded in NZ as this drug presents the best chance for a normal life for sufferers of Cystic Fibrosis like myself. I am trying to gather some data for this purpose.

Can you please provide me with the following information or the closest available information you have if the specifics cannot be provided.

- 1. The lifetime cost, to the DHB, of a lung transplant assuming a person who is 20 years old and has no other significant health issues. Please include the costs of any expected procedures, medicine, follow up care, hopsital stays, etc)
- 2. The lifetime cost, to an individual, of a lung transplant if they were to pursue this through private care. Would this be likely to differ if provided in a different region?
- 3. The lifetime cost, to the DHB, for the care of a person with Cystic Fibrosis assuming they lived till 40 years of age. Please include all expected costs of medication, treatments, hospital visits, medics scans etc).
- 4. The lifetime cost, to the DHB, for the care of a person without Cystic Fibrosis assuming they lived till 40 years of age.

Auckland DHB does not collect cost or activity data from outside of its own hospital. This response does not include:

- Primary care costs
- Pharmacy costs for drugs dispensed outside of the hospital system
- Any contact with private hospitals or other health care providers.
- Any contact with other publicly funded hospitals.

Therefore, we cannot provide a true lifetime cost for patient treatment. We are only able to provide costs related to patients who have had direct contact with Auckland DHB services.

1. The lifetime cost, to the DHB, of a lung transplant assuming a person who is 20 years old and has no other significant health issues. Please include the costs of any expected procedures, medicine, follow up care, hopsital stays, etc)

The estimated lifetime cost of associated hospital treatments for a person aged 20 who also received a lung transplant has been calculated as follows:

• Non lung transplant hospital related costs for cystic fibrosis patients - the cost has been split into age bands as the input required differs by age. The average cost is based on the cost per patient rather than cost per event.

• Lung transplant hospital related costs for cystic fibrosis patients - The inpatient cost of a lung transplant is for the transplant event only. If a patient has multiple admissions before or after the transplant, those costs are contained above. The average cost of a lung transplant (based on financial years 1617-1920) is \$288k

However, they are highly variable in cost depending on complications during treatment.

The total estimated hospital cost for a cystic fibrosis patient aged 20 with a lung transplant, using an age weighted average cost for normal hospital care and an average cost for the lung transplant is \$837k.

Note cystic fibrosis patients may also require other organ transplants. These costs have not been included.

2. The lifetime cost, to an individual, of a lung transplant if they were to pursue this through private care. Would this be likely to differ if provided in a different region?

The private sector does not provide transplantation. Patients may be managed by the private sector for other aspects of their care, but we do not have any data on that. Auckland DHB is the only DHB in the country that provides transplantation. We are unable to provide any information on the other aspects of care provided in other parts of the country.

3. The lifetime cost, to the DHB, for the care of a person with Cystic Fibrosis assuming they lived till 40 years of age. Please include all expected costs of medication, treatments, hospital visits, medics scans etc).

The combined estimated hospital cost of a person with cystic fibrosis without a lung transplant up to the age of 40 is \$1.334m.

4. The lifetime cost, to the DHB, for the care of a person without Cystic Fibrosis assuming they lived till 40 years of age.

Auckland DHB does not collect this sort of data. However, a study by Otago University Medical School published in the New Zealand Medical Journal in 2013 estimated the cost of care for a person up to the age of 40 was \$36k (in \$2011). This is a population based cost and so would

include a portion of cystic fibrosis patients. This impact would be minimal across the total population noting the small number of patients in New Zealand. It includes primary care, hospital care, pharmaceutical and laboratory costs etc.
